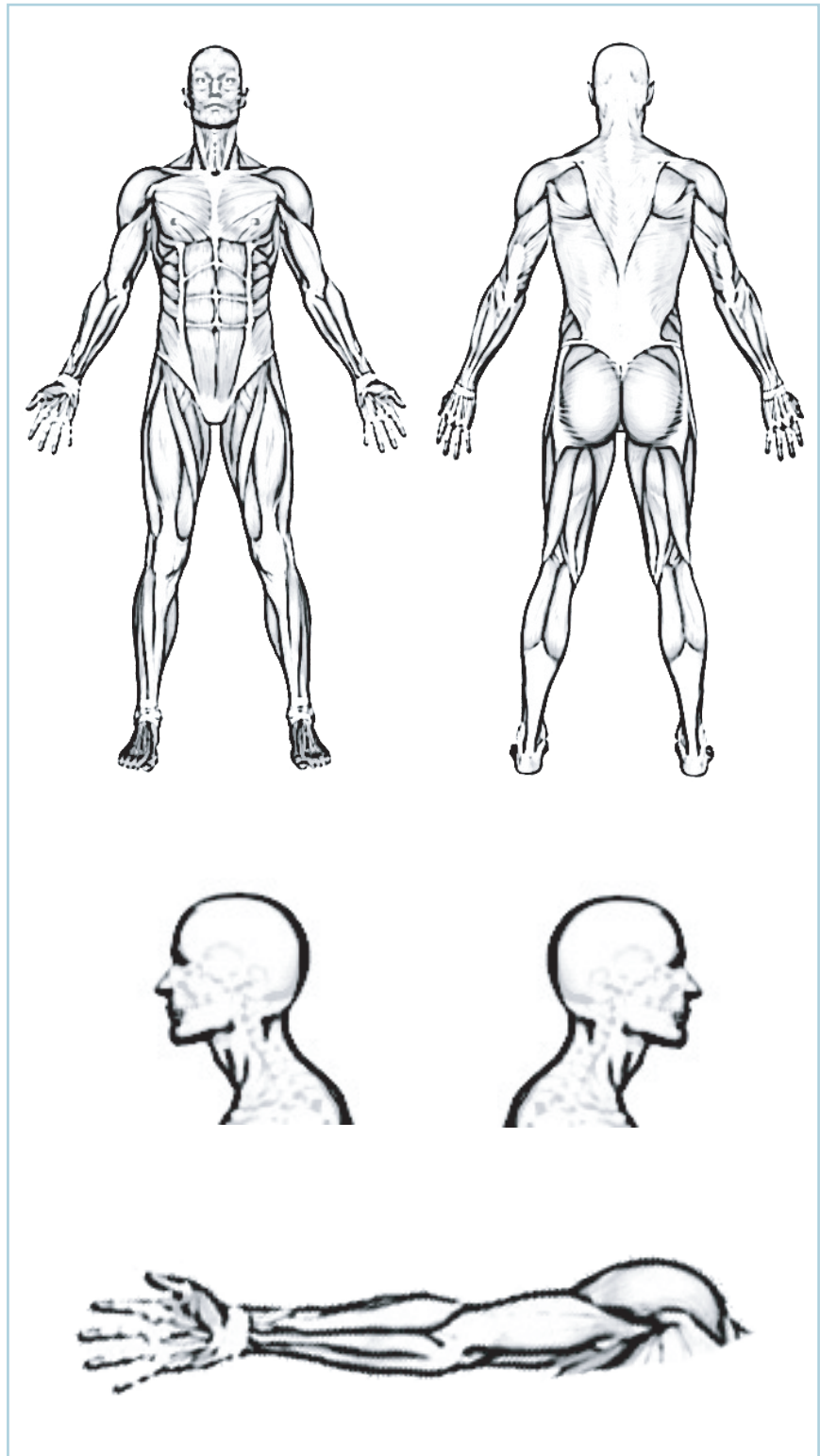

ASSIGNMENT OF BENEFITS: I understand and agree that health and accident insurance policies are an arrangement between my insurance company and myself, not between my insurance company and this office. I hereby assign payment directly to the physician(s) accepting this assignment of medical benefits applicable and otherwise payable to me but not to exceed the physician's regular charges. I understand that I am financially responsible for changes not covered by this assignment or for any and all charges that the insurance carrier declines to pay.

CONSENT FOR TREATMENT: I voluntarily consent to the rendering of care, including treatment and performance of diagnostic procedures. I understand that I am under the care and supervision of the attending physician and it is the responsibility of the staff to carry out the instructions of such physician(s).
